Decided we do not need to distribute among coalition members. The Coalition will support one coalition member event, not the community event. Preference is to do the Stop the Bleed Kits. - Brian's Family Care Objective youth talk to organizations about what to do in regard to family support. Develop resource guide?
 Different from what MCCOY is doing. They do a report, produce a video, townhall? More important than a project is to develop leaders.
- Create a survey (20pt) for where youth are consuming media –
 Educational seminar?
- We need to be intentional about those who are at risk, but not come at them from a place of deficit - How are you staying away from the shootings?
- o It's not the volume of the violence, but the randomness that is especially troubling.
- o Surveys are not the answer. What do we need to do? Learning journey, listening sessions
- Can we be driving them? We need an MOU involved with accepting liability of interns.
- Question regarding interviews. Beatrice wants to handpick her people – trust that she has vetted them (high school students, not college-age) – in order to protect them from an interview / chance to be rejected.
- We are publicly publicizing as well as recruiting youth we already know. All will submit a resume and have an interview. Need to further discuss what that interview looks like.
